## **RESEARCH METHODOLOGY**

**Data Collection Techniques**, Literature study in this research is carried out by collecting various information from relevant sources, such as classical books, scientific articles, and Al-Qur'an verses related to the morals of the Prophet. ## RESULTS AND DISCUSSION

Definition of Akhlak, in language, morals come from the Arabic word *khuluq* which means temperament, character, or character.(daud, 2021) In this context, morals refer to innate traits that determine how a person acts and interacts with their environment. The Arabic language has deep roots, and the word *khuluq* has a close relationship with *khalaq* (creation), which indicates that morals are an integral part of the creation of humans as social and spiritual beings.

In Islamic terms, morals have a deeper meaning. Morals are traits that are embedded in a person's soul and influence behavior spontaneously without the need for excessive consideration. This definition is in line with the opinion of Imam Al-Ghazali, who said that morals are "traits embedded in the soul from which actions emerge without requiring further thought." In other words, morals are a reflection of a person's true character that has been internalized in him.(Mz, 2018)

Al-Ghazali also classified morals into two types, namely akhlak mahmudah (praiseworthy) and akhlak madzumah (despicable). Good morals include traits such as honesty, patience, and compassion, which should be developed in every individual. In contrast, madzumah morals include traits such as envy, pride, and hatred, which should be avoided and strived to be eliminated. This division provides practical guidance for assessing and improving one's character.(Sumirah, 2021)

Morals are also often considered the core of Islamic teachings. The Prophet Muhammad said, "*I was sent to perfect noble character*" (HR Ahmad). This indicates that the Prophet Muhammad's main mission was to set an example in noble morals. In Islam, worship includes not only rituals such as prayer and fasting, but also how one treats fellow human beings and other creatures with compassion and justice.

As a reflection of individual character, morals also play an important role in social relations. A person who has good morals will be easily accepted in society because his behavior reflects respect, honesty, and empathy for others.(Khimzatun, 2021) In the context of family, morals

are the main foundation for creating a harmonious and happy atmosphere. Families whose members have noble morals will find it easier to deal with conflict, strengthen mutual trust, and build strong emotional bonds.

Therefore, an understanding of morals is not only conceptual, but also practical. In daily life, good morals must be shown through concrete actions, such as helping others, forgiving mistakes, and telling the truth. The implementation of good morals is one of the main goals of Islamic education, both at the individual and family levels. #### **A. The Prophet's character,**

Rasulullah SAW is known as a figure who has perfect morals, as expressed by Aisyah RA, who said that the Prophet's character is a direct implementation of the Qur'an: *"His character is the Qur'an"* (HR. Rasulullah always showed extraordinary patience in educating his children, and this is very relevant for parents in educating their children. With patience, parents can provide attentive education without

rushing or showing harshness. For example, the Prophet showed compassion to his children by giving them the time, attention, and love they needed, without rushing to impose his will. Children who are raised with patience and compassion tend to grow up to be patient, understanding, and respectful of others. Teaching these noble morals provides a strong foundation for children to interact with others in a respectful and empathetic manner.

Besides patience, honesty is another very important value in shaping children's character. The Prophet always showed honesty in every aspect of his life. Honesty is not only reflected in his words, but also in his daily actions. He strongly emphasized the importance of speaking the truth and not lying, both to family and others. The Prophet taught that honesty is the foundation on which trust is built, and without honesty, family relationships would be jeopardized. By setting a good example of speaking honestly, parents can instill good habits in their children. Children who grow up in an environment that emphasizes honesty will learn to always tell the truth, maintain integrity, and build healthy relationships with others in the future.

In this case, the Prophet also taught about the importance of responsibility in the family. As the head of the family and leader of the people, the Prophet always carried out his responsibilities very well. He was responsible not only for the physical needs of his family, but also for their spiritual education. Similarly, the Prophet paid equal attention to children in educating them with the right religious values. The application of the value of responsibility in the family includes the role of each family member in fulfilling their respective rights and obligations. For example, a husband must be responsible for the material needs of the family, while a wife also has an important role in supporting the welfare of the family. This responsibility will shape individuals who are independent, disciplined, and have a sense of security in the family.

Not only that, the application of the Prophet's morals also plays a major role in forming a good example for the surrounding community. Families that practice the moral values of the Prophet not only create harmony in the household, but also set a good example for the surrounding community. When a family treats each other with love, patience, honesty, and justice, then they will not only feel happiness in the household, but will also radiate positive energy to the surrounding environment. This example will inspire others to apply the same values in their lives, creating a more caring, empathetic and supportive community. People who see this kind of family example will be more likely to emulate these positive attitudes, and this will lead to better social relations between individuals.

Furthermore, open and loving communication is an equally important aspect in building family harmony. Rasulullah SAW always communicated with his family in a very gentle and respectful manner. In a hadith, the Prophet taught that speaking with kind and loving words is a form of noble character. Effective and loving communication will reduce the potential for conflict and misunderstanding in the family. Children raised in families with good communication will feel more valued and loved. It will also boost the child's self-confidence and provide them with the emotional security necessary to develop properly.

The application of the Prophet's morals in the family also has a major impact on the role of parents as the first educators. Rasulullah taught that parents, especially mothers and fathers, have a great responsibility in educating their children with good morals. By emulating the Prophet's morals, parents can provide a more holistic education, which not only focuses on academic aspects, but also on the formation of children's character and morals.(Anik Indramawan, 2020) Parents who emulate the Prophet will educate their children to become noble individuals, who are not only intellectually intelligent, but also emotionally and socially mature. Good family education will give birth to a generation that is strong in facing life's challenges, who will continuously strive to practice noble morals in their daily lives.

By applying the Prophet's morals in family life, both in husband-wife, parent-child relationships, and in everyday life, the family will become a place filled with love, peace, and happiness. Rasulullah SAW is the best example for Muslims in living a harmonious and blessed family life. His noble character, such as compassion, honesty, patience, and responsibility, is a very strong foundation in creating a family that is not only happy, but also beneficial to the surrounding community.(Djuned & Husna, 2022) Therefore, it is very important for every Muslim family to emulate the Prophet's morals in everyday life, because then, the family will be a source of happiness in this world and the hereafter.

## CONCLUSION

The morals of the Prophet Muhammad have an important role in creating family harmony and forming a generation of noble character. The Prophet not only taught values such as compassion, honesty, patience, and responsibility through words, but also through real examples in daily life. He showed genuine affection to his wife, children and other family members, creating a loving atmosphere that strengthened family relationships. In addition, the Prophet emphasized the importance of justice by not discriminating in the treatment of family members. This justice includes attention, affection, and a balanced division of responsibilities, so that each family member feels valued and has the same opportunity to grow and develop. The responsibilities he exemplified as a husband and father are important guidelines in maintaining family happiness, including ensuring the physical and emotional needs of the family are met.

The application of the Prophet's morals not only has a positive impact on the family, but also has great potential to create a harmonious society. By emulating his compassion, justice and honesty, people can build relationships of mutual respect and support. These values can reduce social conflict and increase solidarity between individuals. Therefore, deepening the understanding of the Prophet's morals is necessary to strengthen healthy social structures and create an environment that supports personal development and shared happiness. The implementation of these moral values is not only a way to carry out religious teachings, but also an effort to build a just, peaceful and developed society.
